Board Update

- Following the Board election results, Bart Kreger and Mike DiSalvo were re-elected and will continue in their current roles each for a 3-year term beginning with the September Board meeting. In addition, we would like to extend a very heartfelt thank you to Ron Ross whose term expired. Ron was a board member for many, many years and did much of the heavy lifting on the maintenance committee. He was responsible for the winter and summer maintenance contracts, taking the lead to oversee the GOF maintenance/upgrades, as well as the overall sewer upgrades and road maintenance. The time and effort put in by Ron allowed the RHSA Board to avoid hiring expensive contractors for the residents to fund. We are grateful for all that he contributed and wish him much deserved rest! • The RHSA Board continues to work with lawyer Greg Fioritto to finalize the Homeowners Association legal documents. The Articles of Incorporation were approved in the Spring. The Declaration of Restrictions vote tabulation is almost complete. This document is being updated for the first time and contains much needed modifications that benefit the entire sub and all homeowners. You will find the proposed updates on the website if you don't have your copy. If you have not yet submitted your form with your vote, please do so as soon as possible - remember that ALL persons on the deed must sign the form. You can contact any Board member to come pick it up, or you can mail to the address noted at the top of this newsletter. We remain hopeful that this can be concluded by the end of the calendar year. - LATE DUES: 2023 Dues were payable by March 31, 2023. If you have not paid these please remit them, plus a \$50 late fee to RIDGEWOOD HILLS SUBDIVISION ASSOCIATION at P. O. Box 5492, Plymouth, MI, 48170. This will avoid a lien being placed on your property and causing additional cost. If you have any questions, please contact our Treasurer, Mike DiSalvo.

- Tree/Shrub Trimming and Weed Maintenance:
 - Thanks to all residents who trimmed the trees and shrubs over sidewalks, both inside the sub and on the outer perimeter, to maintain compliance to the township ordinance. Unfortunately, we are not 100% compliant with this ordinance. The Board continues to receive complaints about it, as well as neighbors not tending to their yards.
